Regular season starts on Monday, September 18, 2017. If you have not handed in ALL of your child's forms, payments and cheques at this time your child WILL NOT be allowed on the ice. *ALL SKATERS IN PRECANSKATE AND CANSKATE ARE REQUIRED TO WEAR A CSA APPROVED HOCKEY HELMET AND GLOVES (ANY TYPE). IF YOU DO NOT HAVE A CSA APPROVED HOCKEY HELMET YOUR CHILD WILL NOT BE ALLOWED ON THE ICE. PLEASE NOTE THAT FACE CAGES ARE NOT MANDATORY BUT ARE RECOMMENDED.

PRECANSKATE (Monday & Wednesday 5:15-5:50pm Tamitik Arena)

This program teaches 3-4 year olds the fundamentals of skating in a fun and creative way. Games, songs, on ice colouring and FUN are used to encourage movement and learning. Skaters in PreCanskate can move on to hockey, figure skating or recreational fun! No skating experience required.

CANSKATE (Monday & Wednesday 5:45-6:35pm Tamitik Arena)

This is a Learn to Skate program for all skaters ages 5 and up. Participants can earn up to 35 badges while they learn fundamental skating skills. Children are grouped by age and skating ability and will be prepared to move on to hockey, figure skating or recreational fun. No skating experience required.

Each registrant has a number of hours required (half for additional child). Hours may be worked or paid out (\$10.25 per hour). The Concession Coordinator will contact you if not paid out on registration.

If choosing to work the hours, a post-dated cheque (dated May 1, 2018) for the full amount is required on registration and will be cashed if the hours are not completed at the end of the season. Maximum 21 hours per family.
